

## Centennial Park Rental Form:

**No rental refunds are available unless the event is cancelled  
by the Park Manager due to inclement weather.**

All persons wishing to rent Centennial Park must read and fill out the form below. After the form is filled out the renter must set up a meeting with the Site Manager and Parks and Recreation Director to discuss additional terms of this agreement.

### Practices:

\$20 per hour (2 hour minimum) plus \$5 per hour of light usage

### Tournaments:

#### Option 1:

- Renter pays \$100 per field per day to include lights if needed
  - Renter keeps 100% of all gate collected
  - Renter keeps 100% of all team entry fees collected
- Renter is responsible for paying umpires/press room workers
- MPR will coordinate concessions and keep 100% of proceeds
  - MPR will be responsible for trash in the complex

#### Option 2:

- Renter pays \$250 per field per day to include lights if needed
  - Renter keeps 100% of all gate collected
  - Renter keeps 100% of all team entry fees collected
- Renter is responsible for paying umpires/press room workers
- Renter will coordinate concessions and keep 100% of total made
  - MPR will be responsible for trash in the complex

**A minimum of 3 fields is required to rent to Centennial Park.**
